A **capital levy fee** is assessed to provide funds that will permit the school to pay for or finance capital improvements such as the construction of new buildings, the improvement of campus facilities, or the purchase of resources, which will enhance the educational program provided for the students.

Tuition fees are payable in 10 installments with payment due on the 5th of each month starting from August 2024 to May 2025. If the due date falls on a weekend or a holiday, then payment is payable on the preceding business day.

Tuition Discount Schemes

Legacy Discount

The following discounts will apply if a family enrolls more than one child.

First child	Full amount is due for the eldest child or the child that is already enrolled.
Second child	A 5% discount of tuition will apply.
Third child	A 10% discount of tuition will apply.
Fourth child and more	A 15% discount of tuition will apply.

Alumnus of YIS/ILBC

If either (or both) parent is an alumnus of YIS/ILBC, then the first child will be considered as the second sibling, and be entitled to a 5% discount.

Note: The greatest discount a student can receive for Legacy Discount is 15%.

Additional Notes

- All fees are non-refundable and non-transferrable.

- Fees are payable by the invoice due date. Any student whose outstanding tuition fees remain unpaid will have their account suspended and will not be able to attend classes until the payment is made. School records, including transcripts and report cards, are released only when all outstanding invoices have been paid.
